SUBMISSION GUIDELINES

- Oral Presentations are invited for the conference.
- Abstracts should not exceed 300 words.
- All submissions must be original and should not have been previously accepted for publication in any journal or presented in any other conference.
- The abstract should be in English and structured as per the following headings: background, method, results/findings, and conclusion.
- The abstract must include details of all authors, particularly their name, designation, affiliation, email address, and phone number. For co-authored work, please indicate the presenter's name.
- Group symposium presentations are also welcome. These should be 1 hour in duration with 4-5 presenters coordinated by one symposium chair. The symposium abstract should not exceed 1000 words and should include a brief introduction followed by individual abstracts. All abstracts must include the title, authors' names, and affiliations, and should be submitted as a single document by the symposium chair.
- Upon acceptance of your paper/symposium, the presenters are required to complete the registration process by paying the associated fee in order to present their research at the conference.
